7. Contest rules	In order to become a Participant of the Contest you must:			
	7.1. In the period from 10:00 local time 05 August 2022 to 23:59 local time 20 September 2022 inclusively, post a video/ photo on instagram / facebook that tells about your experience at a guest house/ winery in Moldova and the activities you had there (eg: gastronomy, accommodation, cycling, etc) The video/photos should contain #HaiLaMineAcasa #taramicainimamare & #beourguest hashtags. The participants's profile must be open.All rights to the contest works submitted belong to the Organizer.			
	<ul> <li>7.2. One Participant (individual) has the right to post an unlimited number of videos/photos.</li> <li>7.3. The winners are determined by the competition jury made up of one</li> </ul>			
	representative from USAID, ANTRIM, the Ministry of Culture, the Investment Agency, the Border Police and the Chisinau International Airport.			
8. Requirements to the Participants'	Requirements to the Participants' contest work.			
contest work.	8.1. The works that are offensive or violate the ethical norms established in the society are unacceptable.			
	8.2. The works which do not correspond to the terms of reference specified on locals.md cannot participate in the Contest.			
	8.3 Only the works of the Participants themselves which do not infringe the copyright and other rights of third parties may be used as a contest work.			
	<ul> <li>8.4 The contest works must correspond to the theme of the Contest, that is to reflect the idea of 'Hai La Mine Acasa':</li> <li>The Contest Participant should be in Moldova at a guest house/winery from Moldova</li> </ul>			
	<ul> <li>The author of the video must show through his video/photos the experience lived at one of the tourist destinations in Moldova.</li> </ul>			

9. Criteria for determining Contest Winners	The Winners – the Grand prize holders and the second-level prize holders of the Contest will be determined as follows:
	9.1. The Contest Organizer announces the Winners based on the results of internal experts' selection.
	9.2. After determining the Winners, the results will be published on <u>Moldova</u> <u>Travel</u> Facebook page
	9.3. The Contest Winners will be informed by publishing the announcement on Moldova Travel Facebook page
10. Participant's rights	The Participant shall have the right:
	10.1 To participate in the Contest in the manner specified by the Rules.
	10.2 To require the award of the Prize in the period until 10 October 2022, if he/she is recognized as the Winner.
11. Participant's obligations.	The Participant shall:
	11.1 Provide reliable data corresponding to the documents proving the identity of the Participant.
	11.2 Sign the necessary documents on the transfer of rights to use his/her work to the Organizer.
12. Organizer's rights.	The Organizer shall have the right:
	12.1 To check and examine the authenticity of contest works.
	12.2 To modify the Rules, while notifying the Participants of the change in the Rules.
	12.4 To request from the Participant additional information required for the Contest.
13. Organizer's obligations.	The Organizer shall undertake:
	13.1 To hold the Contest in the manner specified by the Rules.
	13.2 To award the prize to the Participant recognized as the Winner of the Contest before 10 October 2022.
